PART 1 – EduLAw curriculum update according to the Bologna principles

The EduLAw project sets a framework for the recognition of qualifications in knowledge about education law and the legal framework of education policy and management in the consortium partner countries.

The recognition of qualifications in education law and policy is based on ECTS assigned to the modules used in the program "Educational Administration and Supervision" developed within the EduLAw project, including the development of learning outcomes for the modules with ECTS assigned to EduLAw modules in the curricula of the partner organizations. This would allow transparency and mobility of the students in view of a joint master in education law, policy and management that the consortium would like to establish in next phase.

The EduLaw curriculum update is anchored in the Bologna principles of education reforms and internalization and will result in the formation of the joint master program that will be elaborated between the members of the EduLAw consortium. The proposed curriculum upgrade offered for a 2nd cycle (Mater) level and is logically rooted in the bachelor programs in education and is linked to a third level of the PhD program. Also, the program "Educational Administration and Supervision" reflects the idea of Lifelong Learning, as it attracts the incumbent principles, school administrators and HEIs administration who pursue professional growth and development. The updated master program the is aimed to:

- Develop and apply European credit transfer system;
- Introduce modules taught in the English language, so the language of instruction is going to be partially or completely English;
- Enhance the mobility of students and staff;
- Expand international relations of the program in and outside the consortium;
- Elaborate as well as apply the EU current quality assurance mechanisms based on the European and national standards and guidelines;
- The study periods completed by the students in the consortium members are to be transferred and recognized;
- Expand the social dimension of the existing educational program through the introduction of the module on special needs education.

PART 2

MCU offers updating of master program 44.04.01 "Educational Administration and Supervision", Profile: "Administrator of Educational Organization" (Руководитель образовательной организации) after integrating the EduLaw modules.

The main purpose of the master program - activation of students' professional cognition, ability to see and analyze systemic phenomena in educational policy and pedagogical practices, formation of competence of management in accordance with the requirements of the Federal State Educational Standards in the field of training 44.04.01 "Pedagogical Education" and the prerequisites of professional standards.

The duration of a master degree program is 2 years full-time. The total number of credits - 120 ECTS.
